THIS AGREEMENT, made April 10, 2006, between CUYLER EVANGELICAL COVENANT CHURCH, an Illinois religious corporation, of 1614 West Byron, Chicago, Illinois 60613, herein referred to as "Mortgagor," and NATIONAL COVENANT PROPERTIES, an Illinois not for profit corporation, of 5101 North Francisco Avenue, Chicago, Illinois, herein referred to as "Mortgagee," witnesseth:

THAT WHEREAS Mortgagor is justly indebted to Mortgagee upon that certain First Mortgage Note Secured by Real Estate of even date herewith (the "Note"), in the principal sum of FIVE HUNDRED SIXTY-FIVE THOUSAND and NO/100 DOLLARS (\$565,000.00), payable to the order of and delivered to the Mortgagee, in and by which Note the Mortgagor promises to pay the said principal sum and interest at the rate which is equal to the prime rate of interest as published from time to time in the "MONEY RATES" section of the *Wall Street Journal*, interest payable according to the terms set forth in said Note, with a final payment of all outstanding principal and accrued interest payable in full on demand of Mortgagee, but in no case later than twenty (20) years from the date of first disbursement of loan funds. This Mortgage shall also secure future advances ("Future Advances") from Mortgagee to Mortgagor which, when aggregated with the original principal amount of the Note of even date herewith, do not exceed the principal amount of ONE MILLION and NO/100 DOLLARS (\$1,000,000.00). All of said principal and interest are made payable at such place as the holders of the Note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of Mortgagee at 5101 North Francisco Avenue, Chicago, Illinois 60625.

NOW, THEREFORE, Mortgagor to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of the Note, this Mortgage and any note(s) evidencing any Future Advances, if any, and the performance of the covenants and agreements herein contained, by Mortgagor to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, does by these presents CONVEY AND WARRANT unto Mortgagee, and Mortgagee's successors and assigns, the following described Real Estate and all of the estate, right, title, and interest therein, situate, lying and being in the City of Chicago, COUNTY OF COOK IN STATE OF ILLINOIS, to-wit:

LOTS 24 THROUGH 29, BOTH INCLUSIVE, IN BLOCK 1 OF H. C. BUECHNER'S SUBDIVISION OF BLOCK 1 IN THE SUBDIVISION OF SECTION 19, TOWNSHIP 40 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN (EXCEPT THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4 AND THE SOUTHEAST 1/4 OF THE NORTHWEST 1/4 AND THE EAST 1/2 OF THE SOUTHEAST 1/4 THEREOF) IN COOK COUNTY, ILLINOIS

## THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 2.

1. Mortgagor shall (1) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the Property which may become damaged or be destroyed; (2) keep said Property in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien thereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the Property superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Mortgagee; (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said Property; (5) comply with all requirements of law or municipal ordinances with respect to the Property and the use thereof; (6) make no material alterations in said Property except as required by law or municipal ordinance.
2. Mortgagor shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the Property when due, and shall, upon written request, furnish to Mortgagee duplicate receipts therefor. To prevent default hereunder, Mortgagor shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagor may desire to contest.
3. In the event of the enactment after this date of any law of Illinois deducting from the value of land for the purpose of taxation any lien thereon, or imposing upon Mortgagee the payment of the whole or any part of the taxes or assessments or debts secured by the Mortgage, Future Advances or any other mortgages or Mortgagee's interest in the Property, or the manner of collection of taxes, so as to affect this Mortgage charges or the debt secured hereby or the holder thereof, then and in any such event, Mortgagor, upon demand by Mortgagee, shall pay such taxes or assessments, or reimburse Mortgagee therefor; provided, however, that if in the opinion of counsel for the Mortgagee (a) it might be unlawful to require Mortgagor to make such payment or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then and in such event, Mortgagee may elect, by notice in writing given to Mortgagor, to declare all of the indebtedness secured hereby to be and become due and payable sixty (60) days from the giving of such notice.
4. If, by the laws of the United States of America or any state having jurisdiction in the Property, any tax is due or becomes due in respect of the issuance of the Note and any Future Advances hereby secured, Mortgagor covenants and agrees to pay such tax in the manner required by any such law. Mortgagor further covenants to hold harmless and agree to indemnify Mortgagee, and Mortgagee's successors or assigns, against any liability incurred by reason of the imposition of any tax on the issuance of the Note and any Future Advances secured hereby.
5. At such time as Mortgagor is not in default either under the terms of the Note secured hereby or under the terms of any Future Advances secured hereby or under the terms of this Mortgage, Mortgagor shall have such privilege of making prepayments on the principal of said Note (in addition to the required payments) and any Future Advances (in addition to the required payments) as may be provided in said Note and any Future Advances.
6. Mortgagor shall keep all buildings and improvements now or hereafter situated on said Property insured against loss or damage by fire, lightning, and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to Mortgagee, under insurance policies payable, in case of loss or damage to Mortgagee, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to Mortgagee, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
7. In case of default therein, Mortgagee may, but need not, make any payment or perform any act hereinbefore required of Mortgagor in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise, or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said Property or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other moneys advanced by Mortgagee to protect the mortgaged Property and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the highest rate now permitted by Illinois law. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to Mortgagee on account of any default hereunder on the part of Mortgagor.
8. Mortgagee making any payment hereby authorized relating to taxes or assessments may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
9. Mortgagor shall pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the option of Mortgagee and without notice to Mortgagor, all unpaid indebtedness secured by this Mortgage shall, notwithstanding anything in the Note or any Future Advances or in this Mortgage to the contrary, become due and payable (a) immediately in the case of default in making payment of any installment of principal or interest on the Note or any Future Advances, or (b) when default shall occur and continue for three days in the performance of any other agreement of Mortgagor herein contained.
10. When the indebtedness hereby shall become due whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien hereof. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee for attorneys' fees, appraiser's fees, outlays for documentary and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches, and examinations, title insurance policies, Torrens certificates, and similar data and assurances with respect to title as Mortgagee may deem to be reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the Property. All expenditures and expenses of the nature in this paragraph mentioned

shall become so much additional indebtedness secured hereby and immediately due and payable, with interest thereon at the highest rate now permitted by Illinois law, when paid or incurred by Mortgagee in connection with (a) any proceeding, including probate and bankruptcy proceedings, to which Mortgagee shall be a party, either as plaintiff, claimant or defendant, by reason of this Mortgage or any indebtedness hereby secured; or (b) preparations for the commencement of any suit for the foreclosure hereof after accrual of such right to foreclose whether or not actually commenced; or (c) preparations for the defense of any actual or threatened suit or proceeding which might affect the Property or the security hereof.

11. The proceeds of any foreclosure sale of the Property shall be distributed and applied in the following order of priority: first, on account of all costs and expenses incident to the foreclosure proceedings, including, but not limited to, all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the Note or any Future Advances, with interest thereon as herein provided; third, all principal and interest remaining unpaid on the Note and any Future Advances; fourth, any overplus to Mortgagor, its heirs, legal representatives, or assigns, as its rights may appear.

12. Upon or any time after the filing of a complaint to foreclose this Mortgage, the court in which such complaint is filed may appoint a receiver of said Property. Such appointment may be made either before or after the sale, without notice, without regard to the solvency or insolvency of Mortgagor, at the time of application for such receiver and without regard to the then value of the Property or whether the same shall be then occupied as a homestead or not, and Mortgagee may be appointed as such receiver. Such receiver shall have the power to collect the rents, issues and profits of said Property during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagor, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the Property during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in its hands in payment in whole or in part of: (1) the indebtedness secured hereby, or by any decree foreclosing this Mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.

13. No action for the enforcement of the lien or of any provision hereof shall be subject to any defense which would not be good and available to the party interposing the same in an action at law upon the Note hereby secured or any Future Advances hereby secured.

14. Mortgagee shall have the right to inspect the Property at all reasonable times and access thereto shall be permitted for that purpose.

15. Mortgagor shall periodically deposit with Mortgagee such sums as Mortgagee may reasonably require for payment of taxes and assessment on the Property. No such deposit shall bear any interest.

16. If the payment of said indebtedness or any part thereof be extended or varied or if any part of the security be released, all persons now or at any time hereafter liable therefor, or interested in said Property, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by Mortgagee, notwithstanding such extension, variation or release.

17. Mortgagee shall release this Mortgage and lien thereof by proper instrument upon payment and discharge of all indebtedness secured hereby and payment of a reasonable fee to Mortgagee for the execution of such release.

## RIDER ATTACHED TO FIRST MORTGAGE ("MORTGAGE") BETWEEN CUYLER EVANGELICAL COVENANT CHURCH, MORTGAGOR AND NATIONAL COVENANT PROPERTIES, MORTGAGEE

1. Where the terms of this Rider and Mortgage conflict, the Rider shall control.
2. Transfer of the Property. If all or any part of the Property or any interest in it is sold or transferred without NATIONAL COVENANT PROPERTIES' ("Mortgagee") prior written consent, Mortgagee may, at its option, require immediate payment in full of all sums secured by this Mortgage.
3. Mortgagor shall have the right to repay the Note and any note(s) evidencing any Future Advances, if any, in whole or in part at any time without penalty. Prepayments shall first be applied to the interest due, and then to the remaining principal.
4. In the event that Mortgagor shall breach any obligation under this Mortgage, the Note which it secures, any note(s) evidencing any Future Advances which it secures, if any, or shall:
  - (a) Receive notice that any violation of any Federal, State or local environmental, health or safety law or regulation may have been committed or is about to be committed by Mortgagor in connection with the Property;
  - (b) Receive notice that any administrative or judicial complaint or order has been filed or is about to be filed against Mortgagor alleging violations of any Federal, State or local environmental law or regulation or requiring Mortgagor to take any action in connection with the release of toxic or hazardous substances or release of petroleum or any petroleum product (including, without limitation, crude oil or any fraction thereof) into the environment in connection with the Property;
  - (c) Receive any notice from a Federal, State or local governmental agency or private party alleging that the Mortgagor may be liable or responsible for costs associated with a response to or clean up of a release of toxic or hazardous substance or release of petroleum or any petroleum product (including, without limitation, crude oil or any fraction thereof) into the environment or any damages caused thereby in connection with the Property;
  - (d) Receive any notice that Mortgagor is subject to Federal, State or local investigation evaluating whether any remedial action is needed to respond to the release of any hazardous or toxic waste, substance or constituent, petroleum, or petroleum products (including, without limitation, crude oil or any fraction thereof) or any other substance into the environment in connection with the Property;
  - (e) Incur any additional debt without the prior written consent of Mortgagee;
  - (f) Fail to maintain its affiliation with The Evangelical Covenant Church or its status as an organization exempt from federal taxation pursuant to Section 501(c)(3) of the Internal Revenue Code;
  - (g) Commit fraud or material misrepresentation or material omission on its own account, or by or through any of its officers, directors, trustees, or any guarantor in connection with any one or more of the following:
    - (A) the application for or creation of the indebtedness secured by this Mortgage;
    - (B) any financial information, attendance record or other report or information provided to Mortgagee prior to incurrence of or during the term of the indebtedness secured by this Mortgage; or
    - (C) any request for Mortgagee's consent to any proposed action, including a request for disbursement of funds under any construction escrow or related agreement;

or in the event that:

- (a) Mortgagee shall reasonably deem itself insecure;
- (b) Any proceeding shall be instituted by or against Mortgagor under any bankruptcy or insolvency statute;
- (c) Mortgagor shall make an assignment for the benefit of creditors;
- (d) A receiver shall be appointed for Mortgagor or Mortgagor's property,

Mortgagee may, at its option, without notice or demand, require immediate payment in full of the unpaid principal balance outstanding, any accrued interest, the prepayment premium, if any, and all other amounts payable under the Note

secured by this Mortgage and any note(s) evidencing any Future Advances secured by this Mortgage, if any. Mortgagee may exercise this option to accelerate regardless of prior forbearance.

5. Mortgagor shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the Property which may become damaged or destroyed; (2) keep said Property in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien; and (3) comply with all requirements of law or municipal ordinances with respect to the Property and the use thereof.
6. Mortgagor shall keep all buildings and improvements now or hereafter situated on said Property insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, whichever is greater, all in companies satisfactory to Mortgagee under insurance policies payable, in case of loss or damage, to Mortgagee, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver certificates of insurance evidencing such coverage, to Mortgagee, and in case of insurance about to expire, shall deliver renewal certificates not less than ten (10) days prior to the respective dates of expiration.

Mortgagor agrees to pay reasonable attorneys' fees, costs and expenses incurred by Mortgagee in the collection and enforcement of the above referenced Note and any note(s) evidencing any Future Advances, if any. Any forbearance by Mortgagee in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy.
8. **MORTGAGOR AND MORTGAGEE EACH SEPARATELY AGREE NOT TO ELECT A TRIAL BY JURY WITH RESPECT TO ANY ISSUE ARISING OUT OF THE NOTE SECURED BY THIS MORTGAGE OR THE RELATIONSHIP BETWEEN THE PARTIES AS MORTGAGOR AND MORTGAGEE THAT IS TRIABLE BY A JURY AND WAIVES ANY RIGHT TO TRIAL BY JURY WITH RESPECT TO SUCH ISSUE TO THE EXTENT THAT ANY SUCH RIGHT EXISTS NOW OR IN THE FUTURE. THIS WAIVER OF RIGHT TO TRIAL BY JURY IS SEPARATELY GIVEN BY EACH PARTY, KNOWINGLY AND VOLUNTARILY WITH THE BENEFIT OF COMPETENT LEGAL COUNSEL.**
9. The above terms which are incorporated into the Mortgage referenced above are agreed to and accepted by the Mortgagor.

## FIRST MORTGAGE NOTE SECURED BY REAL ESTATE ("NOTE")

FOR VALUE RECEIVED, CUYLER EVANGELICAL COVENANT CHURCH, an Illinois religious corporation, of 1614 West Byron, Chicago, Illinois 60613 (hereinafter "Debtor") promises to pay to the order of NATIONAL COVENANT PROPERTIES, an Illinois not for profit corporation, of 5101 North Francisco Avenue, Chicago, Illinois 60625, (hereinafter "Lender") the principal sum of FIVE HUNDRED SIXTY-FIVE THOUSAND and NO/100 Dollars (\$565,000.00) lawful money of the United States of America, with interest at a rate equal to the prime rate of interest as published from time to time in the "MONEY RATES" section of the *Wall Street Journal*, payable as follows:

- (a) From the date of the first disbursement of loan funds until paid in full, interest only shall be paid monthly in arrears by the tenth day of each month on the unpaid principal balance outstanding from time to time at a rate equal to the prime rate of interest as published from time to time in the "MONEY RATES" section of the *Wall Street Journal*.
- (b) All outstanding principal and accrued interest hereunder is due and payable in full on demand of Lender, but in no case later than twenty (20) years from the date of first disbursement of loan funds.

All payments on account of the indebtedness evidenced by this Note shall be first applied to accrued and unpaid interest on the unpaid principal balance and the remainder to principal. Each of said installments, to the extent not paid when due, shall bear interest at a rate of interest five (5) points over the rate otherwise applicable to the outstanding principal balance of this Note or at such lesser rate as may be the highest rate then permitted by law. Said payments of both principal and interest shall be made at such place as Lender may, from time to time, in writing appoint, and in the absence of such appointment, then at the offices of Lender, 5101 North Francisco Avenue, Chicago, Illinois 60625.

Borrower shall have the right to prepay this Note in whole or in part at any time without penalty. Prepayments shall first be applied to the interest due, and then to the remaining principal.

The payment of this Note is secured by a First Mortgage ("Mortgage"), bearing even date herewith, to National Covenant Properties, Mortgagee, on real estate in the County of Cook, State of Illinois (hereinafter "Property"). Said Mortgage contains the following provision:

**Transfer of the Property.** If all or any part of the Property or any interest in it is encumbered, sold or transferred without the prior written consent of Mortgagee, Mortgagee may, at its option, require immediate payment in full of all sums secured by this Mortgage.

Borrower shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the Property which may become damaged or destroyed; (2) keep said Property in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien; and (3) comply with all requirements of law or municipal ordinances with respect to the Property and the use thereof.

Borrower shall keep all buildings and improvements now or hereafter situated on said Property insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, whichever is greater, all in companies satisfactory to Lender under insurance policies payable, in case of loss or damage, to Lender, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver certificates of insurance

evidencing such coverage, to Lender, and in case of insurance about to expire, shall deliver renewal certificates not less than ten (10) days prior to the respective dates of expiration.

In the event that Borrower shall breach any obligation under this Note or under the terms of the Mortgage given to secure this Note or shall:

- (a) Receive notice that any violation of any Federal, State or local environmental, health or safety law or regulation may have been committed or is about to be committed by Borrower in connection with the Property;
- (b) Receive notice that any administrative or judicial complaint or order has been filed or is about to be filed against Borrower alleging violations of any Federal, State or local environmental law or regulation or requiring Borrower to take any action in connection with the release of toxic or hazardous substances or release of petroleum or any petroleum product (including, without limitation, crude oil or any fraction thereof) into the environment in connection with the Property;
- (c) Receive any notice from a Federal, State or local governmental agency or private party alleging that the Borrower may be liable or responsible for costs associated with a response to or clean up of a release of a toxic or hazardous substance or release of petroleum or any petroleum product (including, without limitation, crude oil or any fraction thereof) into the environment or any damages caused thereby in connection with the Property;
- (d) Receive any notice that Borrower is subject to Federal, State or local investigation evaluating whether any remedial action is needed to respond to the release of any hazardous or toxic waste, substance or constituent, petroleum or petroleum products (including, without limitation, crude oil or any fraction thereof) or any other substance into the environment in connection with the Property;
- (e) Incur any additional debt without the prior written consent of Lender;
- (f) Fail to maintain its affiliation with The Evangelical Covenant Church or its status as an organization exempt from federal taxation pursuant to Section 501(c)(3) of the Internal Revenue Code;
- (g) Commit fraud or material misrepresentation or material omission on its own account, or by or through any of its officers, directors, trustees, or any guarantor in connection with any one or more of the following:
  - (A) the application for or creation of the indebtedness evidenced by this Note;
  - (B) any financial information, attendance record or other report or information provided to Lender prior to incurrence of or during the term of the indebtedness evidenced by this Note; or
  - (C) any request for Lender's consent to any proposed action, including a request for disbursement of funds under any construction escrow or related agreement;

or in the event that:

- (a) Lender shall reasonably deem itself insecure;

- (b) Any proceeding shall be instituted by or against Borrower under any bankruptcy or insolvency statute;
- (c) Borrower shall make an assignment for the benefit of creditors;
- (d) A receiver shall be appointed for Borrower or Borrower's property,

Lender may, at its option, without notice or demand, require immediate payment in full of the unpaid principal balance outstanding, any accrued interest, and all other amounts payable under this Note. Lender may exercise this option to accelerate regardless of prior forbearance.

Borrower agrees to pay reasonable attorneys' fees, costs and expenses incurred by Lender in the collection and enforcement of this Note. Any forbearance by Lender in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy.

**BORROWER AND LENDER EACH SEPARATELY AGREE NOT TO ELECT A TRIAL BY JURY WITH RESPECT TO ANY ISSUE ARISING OUT OF THIS NOTE OR THE RELATIONSHIP BETWEEN THE PARTIES AS LENDER AND BORROWER THAT IS TRIABLE BY A JURY AND WAIVES ANY RIGHT TO TRIAL BY JURY WITH RESPECT TO SUCH ISSUE TO THE EXTENT THAT ANY SUCH RIGHT EXISTS NOW OR IN THE FUTURE. THIS WAIVER OF RIGHT TO TRIAL BY JURY IS SEPARATELY GIVEN BY EACH PARTY, KNOWINGLY AND VOLUNTARILY WITH THE BENEFIT OF COMPETENT LEGAL COUNSEL.**

This document may be executed in any number of counterparts, each of which shall be deemed an original and all of which shall constitute one instrument with the same effect as if all parties had signed the same signature page. Any signature page of this document may be detached from any counterpart and be reattached to any other counterpart identical in form hereto but having attached to it one or more additional signature pages.

All parties hereto severally waive presentment for payment, notice of dishonor, protest and notice of protest.
