There are no tenants as this is new construction.

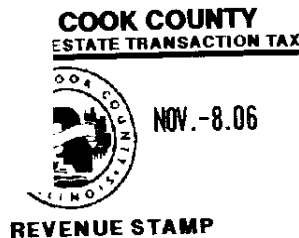
