As used in this Section 16, "Interest in the Property" means any legal or beneficial interest in the Property, including, but not limited to, those beneficial interests transferred in a bond for deed, contract for deed, instantient sales contract or escrow agreement, the intent of which is the transfer of title by Borrower at a future date to a purchaser.
