THIS SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR THE 2204 N. NATCHEZ CONDOMINIUM (the "Amendment") is made this 31 day of October, 2006, by **Natchez-Palmer LLC**, an Illinois limited liability company (the "Declarant").

RECITALS

WHEREAS, Declarant is the owner in fee simple of certain real estate, hereinafter described, in Chicago, Cook County, Illinois; and

WHEREAS, a Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By Laws for the Natchez-Palmer I Association, 2204 N. Natchez Condominium dated March 16, 2006 was recorded in the Office of the Cook County Recorder (the "Recorder") on March 21, 2006 as Document No. 0608010147, as amended by that certain Amendment to Declaration of Condominium Ownership for the 2204 N. Natchez Condominium dated April 13, 2006, and recorded with the Recorder on April 13, 2006, as Document No. 060317104 (collectively, the "Declaration").

WHEREAS, there were clerical errors made in the Declaration which need to be corrected;


NOW, THEREFORE, in consideration of the above recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Declarant desires to amend the Declaration as stated below.

1. The cover sheet of the Declaration is amended by deleting the number "2004" contained thereon and replacing it with the number "2204".
2. The definition of "Common Elements" contained in Section 3.1 of the Declaration is revised to include the two (2) outdoor parking spaces located within the Common Elements of the condominium (the "**Outdoor Parking Spaces**"). The Outdoor Parking Spaces are and shall remain common elements, the use thereof to be regulated by the Association (as defined in the Declaration).
3. The legal description contained in Section 2.1.1 of the Declaration is deleted in its entirety and replaced with the new legal description attached hereto as Replacement Exhibit A-1.
4. The legal description contained in Exhibit A of the Declaration is deleted in its entirety and replaced with the new legal description attached hereto as Replacement Exhibit A-1.
5. Section 4.5.1 is amended by deleting references to Lot 11 of the Parcel and replacing all such references with references to the driveway for ingress and egress for parking, all as more fully described on Exhibit A-1 attached hereto.



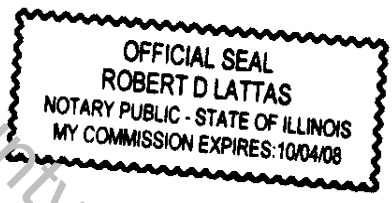
