American Chartered Bank, mortgagee; 670 Alice Corporation, an Illinois corporation (hereinafter referred to as 'owner'); and any persons or entities claiming to be interested in the real estate described herein, and states:
- 2. Since April 10, 2006, the owner has owned the following described land in the County of Cook, State of Illinois, to-wit:

3. On or about November 11, 2005, Ibarras Cement made an oral contract with the claimant to deliver ready-mix concrete and related materials, under Ibarras Cement's contract with the owner

Bierman's authority or knowing permission for the improvement of said premises, and that the claimant completed delivery of all required materials for the sum of \$16,611.71. The claimant completed delivery of said ready-mix concrete and related materials on July 17, 2006.

4. The owner is entitled to credits on account thereof as follows, to-wit: \$13,492.49, leaving due, unpaid and owing to the claimant, after allowing all just credits, the sum of \$3,119.22, for which, with statutory interest at the rate of 10% per annum, the claimant claims a lien on said land and improvements and on the monies and other consideration due or to become due from the owner under said contract and against said contractor and owner.
