MEMORANDUM OF AGREEMENT

For good and valuable consideration, pursuant to the terms of the Agreement and specifically the Buyer Addendum attached thereto Buyer has granted to Seller certain rights and remedies in the event Buyer conveys or transfers, or attempts to convey or transfer, Buyer's interest in the Property for a period of one (1) year from the date of recordation of this Memorandum. In the event of Buyer's actual or attempted conveyance or transfer within such one (1) year period Seller may elect, in its sole discretion, to either (i) receive payment by Buyer of damages in an amount equal to the difference between (a) the fair market value of the Property at the time of Buyer's sale or other transfer of the Property, less Buyer's customary costs of resale (such as broker's commission, escrow fees and title costs) actually incurred by Buyer, and (b) the Purchase Price set forth in the Agreement, plus the actual cost of any permanent improvements made by Buyer to the Property, or (ii) repurchase the Property from Buyer as more fully set forth in the Agreement.
