

5. Property Insurance. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. I will make my monthly payments on the first day of each month beginning on January 1, 2007. Each of these dates is called a "Payment Due Date." I will make these payments every month until I have pair, all of the Principal and interest and any other charges described below that I may owe under this Note. My monthly payments will be applied as of the scheduled Payment Due Date and will be applied to interest before Principal. (iv) Full Payment. At all times during the term of this Note I will have the option of paying the Full Payment. Starting with the 121st Payment Due Date, I will be required to make the Full Payment. At least 30 days before each Payment Change Date, the Note inclder will calculate the amount of the monthly payment that would be sufficient to repay the remaining unpaid Principal in full on the Maturity Date in substantially equal installments at the interest rate, determined in accordance with Section 2, in effect during the month preceding the Payment Change Date. The result of this calculation is called the "Full Payment."

(e) Limit on My Unpaid Principal; Increased Monthly Payment
