



WHERAS, the Plat of Survey attached to the Declaration as Exhibit B depicts ninety-six (96) limited common element storage spaces ("Storage Spaces") in the Basement (Page 2 of 6), but neither the Plat of Survey nor the Declaration indicate the Units that are exclusively served by the Storage Spaces;

- 2. The Developer reserves the right to further amend the Declaration to depict the Units exclusively served by the ary Storage Spaces not so designated by this Amendment.
- 3. All the Unit Owners and mortgage holders, by the Declarant, hereby consent to this Amendment to the Declaration pursuant to the powers set forth in Article XII of the Declaration.
