WHEREAS the Declarant pursuant to Section 13.12 of the Declaration of Condominium Ownership recorded on May 26, 2004 desires and intends by this Special Amendment to the Declaration to correct Article 7 paragraph 7.1(e) to change the last sentence thereunder from 'core (1) dog" to "two (2) dogs whose cumulative weight cannot exceed sixty (60) pounds" with the remainder of said paragraph remaining the same.

NOW, THEREFORE, as the Declarant and Developer and for the purposes above set forth, hereby modifies and corrects Article 7, paragraph 7.1 (e) so that paragraph 7.1(e) shall reflect the following it its entirety:

(e) No animals or reptiles shall be raised, bred or kept in any Unit or the Common Elements, except, with respect to Units, for animals which are of a breed or variety commonly kept as household pets in first-class condominium buildings located in Chicago, are not kept or bred for any commercial purpose, are not allowed to run loose on the Property, are bent in strict accordance with such rules and regulations relating to household pets as may be from time to time adopted or approved by the Board, and do not, in the judgment of the Board, constitute a nuisance to others. Each Unit Owner and each occupant shall be responsible for picking up after any animal kept in such Unit Owners or Occupant's respective Unit, including, without limitation, removing any we see deposited by such animal anywhere on the Common Elements or anywhere on the Property. Not withstanding anything to the contrary contained herein, no more than two (2) dogs whose cumulative veight cannot exceed sixty pounds may be kept in any Unit at any one time.
