THIS MODIFICATION OF MORTGAGE dated December 14, 2006, is made and executed between George V. Poovathur, Married to Ponnamma G. Poovathur (referred to below as "Grantor") and CHICAGO COMMUNITY BANK, whose address is 1110 WEST 35TH STREET, CHICAGO, IL 60609 (referred to below as "Lender").

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

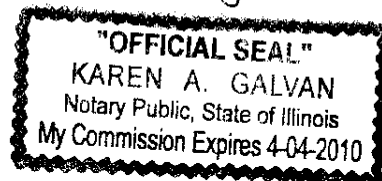
