

#### FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM FOR 37.06 N. GREENVIEW CONDOMINIUM

This FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM FOR 3706 N. GREENVIEW CONDOMINIUM made and entered into this 5th lay of February, 2006 by ANDREA L. SAIA, (hereinafter referred to as "Declarant").

WHEREAS, by a Declaration of Condominium ("Declaration") recorded in the Recorder's Office of Cook County, Illinois, as Document number 0527810127, the Declarant submitted certain real estate to the provisions of the Illinois Condominium Act ("Act"); and

WHEREAS, the Declarant now desires to amend Exhibit Byf the Declaration.

WHEREAS, the Declarant desires to add a provision to Paragraph 5 of the Declaration to grant an easement to all Unit Owners and their agents to the entry located on the Garden Level to Unit Terrace for purposes of accessing the fuse boxes and entry into and out of the Unit Terrace to access the water heaver and heating room located in the Unit Terrace.

NOW, THEREFORE, the Declarant does hereby amend the Declaration as follows:

- Exhibit B of the Declaration is hereby amended by deleting said Exhibit B and substituting therefore 1. Exhibit B attached hereto.
- Paragraph 5 of the Declaration is hereby amended by adding the following new paragraph (g) after 2. paragraph (f) thereof:
  - "(g) Easements are hereby declared and granted to Unit Owners and their agents for ingress and egress to and from (i) the entry located on the garden level to Unit Terrace for purposes of accessing the fuse boxes when necessary for repair, maintenance, or replacement, and (ii) the entry into and out of the Unit Terrace to access the room designated in the Plat of Survey as the water heater and heating room located in the Unit Terrace for purposes of the repair, maintenance or replacement of the mechanical equipment located therein and servicing more the other Units or common areas in addition to the Terrace Unit. All persons entering the easement area shall not unreasonably interfere with the use and quiet enjoyment of the Terrace Unit by the Terrace Unit Owner."

Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
