# Illinois Statutory Short Form Power of Attorney for Property

NOTICE: The purpose of this power of attorney is to give the person you designate (your "agent") broad powers to andle your property, which may include powers to pieage, sell or other wise dispose of any real or personal property eithout advance notice to you or approval by you. This form does not impose a duty on your agent to exercise granted owers; but when powers are exercised, your agent will have to use due care to act for your benefit and in accordance with this form and keep a record of receipts, disbursements and significant actions taken as agent. A count can take away he powers of your agent if it finds the agent is not acting properly. You may name surcessor agents under this form nut not co-agents. Unless you expressly limit the duration of this power in the manner provided below, until you revoke his power or a count acting on your behalf terminates it, your agent may exercise the powers given here throughout your itetime, even after you become disabled. The powers you give your agent are explained more fully in Section 3-4 of the llinois "Statutory Short Form Power of Attorney for Property Law" of which this form is a part (see the Lack of this form). That law expressly permits the use of any different form or power of attorney you may desire. (If there is enything about his form that you do not understand, you should ask a lawyer to explain it to you.)
