## MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated August 30, 2005, is made and executed between Benjamin Munoz (referred to below as "Grantor") and COLE TAYLOR BANK, whose address is 111 W. WASHINGTON, CHICAGO, IL 60602 (referred to below as "Lender").

principal amount of Indebtedness secured by the Mortgage, not including sums advanced to protect the security of the Mortgage, exceed \$2,978,000.00.

The definition of the Note within the Mortgage is hereby modified to mean the follow:

A Promissory Note dated February 18, 2005, in the original principal amount of \$610,000.00 as modified, extended and/or increased from time to time, and a Promissory Note dated January 27, 2005, in the original principal amount of \$250,000.00, increased to \$450,000.00 as of January 27, 2006, as modified, extended and/or increased from time to time, and a Promissory Note dated July 20, 2005, in the original principal amount of \$85,000.00 as modified, extended and/or increased from time to time, and a Promissory Note dated August 28, 2006, in the original principal amount of \$152,000.00 as modified, extended and/or increased from time to time, and a Promissory Note dated August 30, 2006, in the original principal amount of \$192,000.00, as modified, extended and/or increased from time to time, all from Grantor to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of and substitutions for the Promissory Note(s) or Agreement(s) not yet paid.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and elfect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or enderser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
