Page 8 "item 20" of the Declaration of Condominium of the Oglesby Avenue Condominium Corporation, which Declaration was recorded in the office of the Recorder of Deeds of Cook County on December 29, 1977, as Document number 24264233, is hereby Amended to provide as follows:

Page 8 "Item 20"  
Sale or Lease by a Unit Owner  
To include  
Prohibit Leasing/Rental by a Unit Owner

**Prohibit Leasing/Rental by a Unit Owner.** No Owner of any unit may permit his or her Living Unit to be leased, rented or otherwise let to any person or entity that is not the fee simple owner of the unit. It is the intention of the Owners of Oglesby Avenue Condominium Corporation that all persons residing in the Living Units shall be Owners of the property and that neither the Living Unit nor any portion of it shall in any way be occupied by tenants or renters.

Notwithstanding the above, nothing in this section is meant to prevent the Association from renting any unit that comes under Association control, either through eviction of a unit owner, the exercise of the Association's Right of First Refusal, or any other manner in which the Association should come into possession or ownership of one of the units.


