

TRAFFIC AND PARKING ENFORCEMENT AGREEMENT

The Drury Lane Homeowners Association of Drury Lane Road, Northfield, Illinois, hereby enter into this agreement with the Northfield Police Department pursuant to 625 ILCS 5/11-200 of the Illinois Vehicle Code, as attached hereto and made a part hereof, authorizing the Northfield Police Department to enforce all traffic and parking regulations of the Village of Northfield and the State of Illinois on private Drury Lane, (2200 Block).

It is further agreed that appropriate signage, as determined by the Chief of Police, will be posted at the Association's expense.

This agreement shall be recorded pursuant to statute in the Office of the Recorder of Cook County, and no regulation made pursuant to this contract shall be effective or enforceable until 3 days after the contract is so recorded.

This agreement is unconditionally cancelable by either party upon 30 days written notice to the other party.

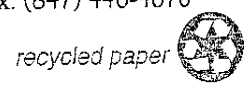
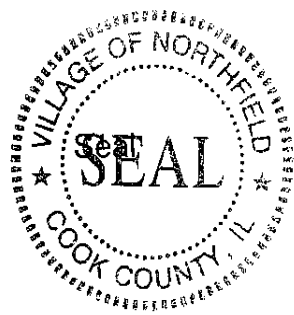

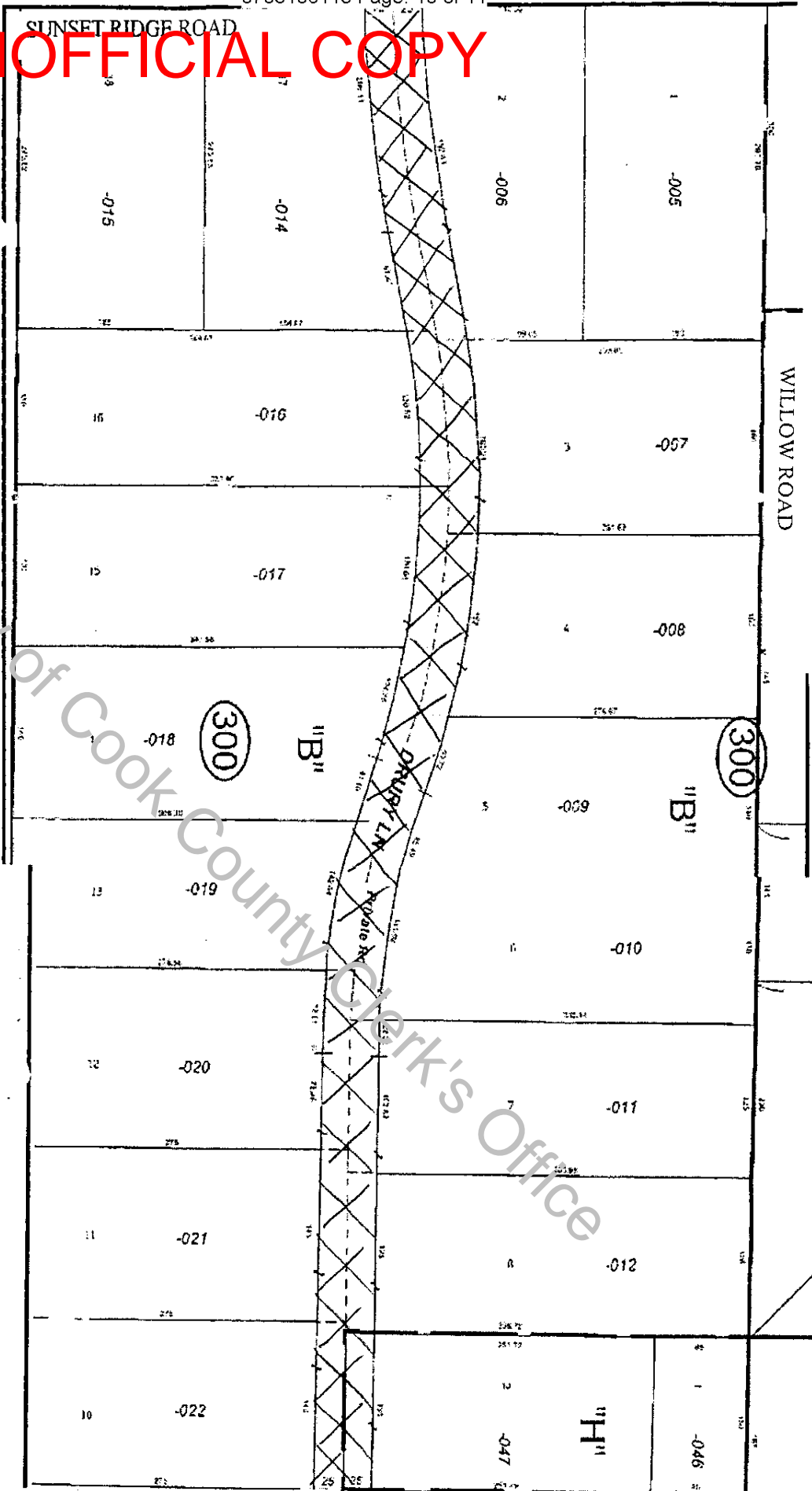
