SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS, AND BY-LAWS FOR THE WOODLANDS OF BRONZEVILLE CONDOMINIUM ASSOCIATION

THIS SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS, AND BY-LAWS FOR THE WOODLANDS OF BRONZEVILLE CONDOMINIUM ASSOCIATION (this "Second Amendment") is made this 6 day of February, 2007 by Woodland Park Associates LLC, an Illinois limited liability company ("Declarant").

RECITALS

A. Declarant previously made and entered into that certain Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for The Woodlands of Bronzeville Condominium Association, dated as of June 30, 2006, which was recorded against the real property described in Schedule 1 attached hereto and hereby made a part hereof (the "Parcel") on the same date in the Office of the Recorder of Deeds of Cook County, Illinois (the "Official Records") as Document No. 0618117037 for the purposes of submitting the Submitted Parcel to the provisions of the Condominium Property Act of the State of Illinois (the "Act"), and thereafter amended by that certain First Amendment to Declaration of Condominium Ownership and of Easements, Restrictions, Covenants, and By-Laws for The Woodlands of Bronzeville Condominium Association, dated as of October 9, 2006, which was recorded against the Parcel on October 18, 2006 in the Official Records as Document No. 0629110048 and re-recorded against the Parcel on November 13, 2006 in the Official Records as Document No. 0631718075 (as so amended, the "Declaration").

B. Developer is the owner of a fee simple estate in the real property (the "Additional Parcel") described in Schedule 2 attached hereto and hereby made a part hereof which is a portion of the Future Expansion Parcel (as defined in the Declaration), together with the improvements located thereon.

C. Declarant now desires to annex and add the Additional Parcel to the property (the "Property") subject to the Declaration pursuant to Article 12 thereof, and to revise certain provisions of the Declaration as needed to refer to the annexation and addition of the Additional Parcel.

NOW THEREFORE, Woodland Park Associates LLC as the Declarant under the Declaration, and for the purposes set forth above, **DECLARES AS FOLLOWS:**

1. The foregoing recitals are hereby incorporated by reference as if set forth fully herein. All capitalized terms not defined in this Second Amendment shall have the same meanings ascribed thereto in the Declaration.

2. The Declaration is hereby amended to submit the Additional Parcel legally described in Schedule 2, attached hereto and hereby made a part hereof, together with all improvements now or hereafter constructed thereon, to the provisions of the Act, and to the terms and provisions of the Declaration.

3. Exhibit A attached to the Declaration, which sets forth the legal description of the Property and the Plat of Survey of the Condominium (as therein defined), is hereby amended and supplemented as follows: (i) Page No. 1 of Exhibit A is hereby deleted in its entirety and replaced with Page No. 1 attached hereto; and (ii) Page No. 1A, Page No. 6, Page No. 7, Page No. 8 and Page No. 9 attached hereto are hereby appended to Exhibit A of the Declaration.

4. Exhibit B attached to the Declaration, which sets forth all of the Units in the Condominium and their respective percentages of ownership interests in the Common Elements (as therein defined), is hereby deleted and Exhibit B attached hereto and made a part hereof, is hereby substituted therefor.

5. Exhibit C attached to the Declaration, which contains the legal description of the Future Expansion Parcel, is hereby deleted and Exhibit C, attached hereto and made a part hereof, is hereby substituted therefor.

4. All terms, conditions and provisions of the Declaration, as expressly amended and supplemented by this Second Amendment, are hereby ratified, confirmed and shall continue to apply with full force and effect. In the event of any inconsistency between this Second Amendment and the Declaration, this Second Amendment shall control.
