MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 1, 2007, is made and executed between Exchange Place, LLC, an Illinois limited liability company, whose address is 648 E. 101st Street, Chicago, IL 60628 (referred to below as "Grantor") and NEW CENTURY BANK, an Illinois banking corporation, whose address is 363 W. 

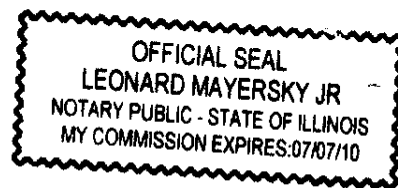
