- 1. That it has jurisdiction of the parties and the subject matter;
- 2. That pursuant to the Warranty Deed executed on March 10, 2003, LUCIOUS BOYKIN is the owner in fee simple of certain real estate situated in Cook County, Illinois and described in the complaint as follows:
