- In January 2005, Owner owned the real estate in the County of Cook, State of 1. Illinois, commonly known as 1525 E. 53rd Street, Cricago, Illinois ("Property") and legally described on Exhibit A attached hereto.
- On information and belief, prior to September 1, 2005, Owner or Occupant, who 2. was knowingly permitted by Owner to improve the Property, entered into a contract with Contractor for Contractor to act as general contractor for the installation of new lobby doors and portal and other construction work to be performed on the lobby at the Property
- On or about September 1, 2005, MTH entered into a written contract with 3. Contractor whereby MTH agreed to perform certain work for the lobby of the Property including but not limited to furnishing all necessary labor and certain requested materials to install Ellison doors and Elllison portal, all related hardware, and to furnish and install glass at the canopy (hereinafter collectively "the Project"). Contractor agreed to pay MTH the sum of \$71,030.00 for performance of this work on the Project.
- That at the special instance and request of Contractor, MTH furnished extra and additional materials and additional labor on Property with a value of \$43,182.00.
- The total amount due by Contractor to MTH under the contract, change orders and purchase orders between Contractor and MTH was \$114,212.00.
- That MTH substantially completed all that was required by said contracts, change orders, and requests for extras on November 11, 2006.

After allowing all credits, the sum of \$11,421.00 is due. MTH claims a lien on the Property in the amount of \$11,421.00 plus interest and on the money or other consideration due or to become due from the Owner or Occupant against all persons interested.
