



All defined terms herein shall have their meaning assigned to them in the Purchase Agreement

19. RIGHT OF REPURCHASE.

- (a) Purchaser hereby represents and warrants as of the date hereof and as of the Closing Date that Purchaser is acquiring the Dwelling Unit for personal use and not for resale or lease and that in acquiring the Dwelling Unit, Purchaser is not acting as agent or numinee for any undisclosed party. Purchaser hereby grants Seller a right to repurchase the Dwelling Unit on the term's and conditions hereinafter set forth.
