ADDITIONAL CONVENANTS CONDITIONS AND PROVISIONS REFERRED TO ON THE REVERSE SIDE OF THIS MORTGAGE AND INCORPORATED THEREIN BY REFERENCE.

1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free of mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof and upon request exhibit satisfactory evidence of the discharge of such prior lien to Mortgagee or to holder of the Contract; (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof, (6) make no material alterations is said premises except as required by law or municipal ordinance.

2. Mortgagors shall pay before any penalty attaches all general taxes and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall upon written request, furnish to Mortgagee or to holders of the Contract duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which

Mortgagors may desire to contest.

Mortgagors shall keep all buildings and improvements now and hereafter situauted on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of money sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness, secured hereby, all in companies satisfactory to the holders of the Contract, under insurance policies payable, in case of loss or damage, to Mortgagee, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies including additional and renewal policies to holder of the Contract and in case of insurance about to expire, shall deliver renewal policies not less than ten

days prior to the respective dates of expiration.

In case of default therein, Mortgagee or the holder of the Contract may, but need not, make any payments or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture, affecting said premises or confect any tax or assessment. All moneys paid for any of these purposes herein authorized and all expenses paid or incurred in connection therewith, including thorneys' fees and any other moneys advanced by Mortgagee or the holders of the Contract to protect the premises and the lien hereof, shall be so much add tio all indebtedness secured hereby and shall become immediately due and payable without notice. Inaction of Mortgagee or holders of the Contract shall never be considered as a waiver of any right accruing to them on account of any default hereunder on the part of Mortgagors.

9. Upon, or at any time after the filing of a suit to foreclose this Mortgage the court in which such suit is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale without notice, without regard of the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same stall be then occupied as a homestead or not and the Mortgagee hereunder may be appointed as such receiver. Such receiver shall have power to collect render the same stall premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency during a full statutory period of red mption, whether there be redemption on not, as well as during any further times when Mortgagors, except for the intervention of such receiver would be entitled to collect such reats, issues and profits and well as during any further times when Mortgagors, except for the intervention of such receiver, would be entit et to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in his hards in payment in whole or in part of: (1) the indebtedness secured hereby, or by any decree foreclosing this Mortgage or any tax, special assessment or other line which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of such application is made prior to foreclosure sale;

10. No action for the enforcement of the lien or any provision hereof shall be subject to any defense which would not be good and available to the party

If Mortgagors shall sell, assign or transfer any right, title or interest in said premises, or any portion thereof, without the written consent of the holder of the Contract secured hereby, holder shall have the right, at holder's option, to declare all unpaid indebtedness secured by this Mortgage to be immediately due and payable, anything in said Contract or this Mortage to the contrary notwithstanding.
