The Subcontractor's Work was part of the Work that Prime Contractor was obligated to perform for Owner under a prime construction contract (the "Prime Contract") between Prime Contractor and Owner for improvement of the Real Estate for the Project known as Costco Wholesale Warehouse, 9915 West 159th Street, Orland Park, Illinois (the "Project").
- 4.
