THE UNDERS. CNED LIEN CLAIMANT, Warren F. - 1. On or about September 28, 2006, Cyrner owned the following described real estate in the County of Cook, State of Illinois, to wit: See lego! description attached hereto and incorporated herein as **Exhibit A**, commonly known as 163 E. Walton Street, Chicago, Cook County, IL, which real estate has the following permanent index number: 17-03-213-002-0000 and which is hereinafter together with all improvements referred to as the "premises."
- 2. On a date unknown to Lien Claimant, Owner, or one knowingly permitted by the Owner to do so, entered into a contract with Contractor wherein Contractor was to provide labor, materials and equipment for the construction, alterations and improvements to and for the benefit of the premises.
- 3. On or about September 28, 2006, Subcontractor submitted a writter proposal to Contractor in the amount \$19,650.00 to provide plumbing labor and material identified in Drawing KBH/ID/GR\_BD-101 provided to Lien Claimant from Contractor. Shortly thereafter, Contractor orally accepted Lien Claimants proposal and directed Lien Claimant to furnish and supply and supply said plumbing labor, materials, fixtures and equipment to the premises in the amount of \$19,650.00 for said improvement.
- 4. At the special instance and request of Contractor, lien claimant furnished extra and additional materials to and extra and additional labor for said premises in the amount of \$5,558.00.

- 5. On January 12, 2007, Lien Claimant substantially completed all required by said contract and extras to be done.
- 6. Contractor is entitled to credits on account thereof as follows: \$0, leaving due, unpaid and owing to Lien Claimant, after allowing all credits, the sum of \$25,208.00 for which, with interest, Lien Claimant claims a lien on the premises and improvements and to monies or other considerations due or to become due from Owner under said contract between Contractor and Owner.
- Notice has been duly given to Owner, the Lender and the Contractor as required by the Illipois Mechanics Lien Act, 770 ILCS 60/24. On information and belief notice has also been given to the Owner and others pursuant to 770 ILCS 60/5.
