LIMITED POWER OF ATTORNEY

Ameriquest Mortgage Company, a Delaware corporation ("Ameriquest") and Argent Mortgage Company, LLC, a Delowere limited liability company ("Argent" together with Ameriquest the "Seller") hereby appoints Parclay's Capital Real Estate Inc., dba HomEq Servicing ("HomEq" or "Master Servicer"), as its ore and lawful attorney-in-fact to act in the name, place and stead of Seller for the purposes set forth lelow.
