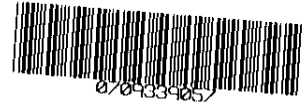

11. Based upon my own personal knowledge and belief, the foregoing is true and if called upon as a witness I will completely and consistently testify thereto.

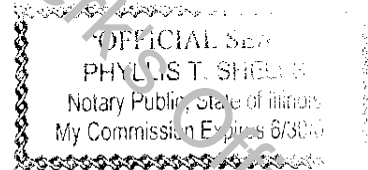
