#### **EXHIBIT A**

To administer, regulate, maintain and operate certain property commonly known as 1224 West Van Buren, located in the City of Chicago, County of Cook, State of Illinois, together with all improvements and structures constructed or erected thereon, all fixtures, equipment and personalty contained therein, and all easements, rights and appurtenances belonging thereto, which are intended for the mutual use, benefit and enjoyment of the members of the corporation, and such additions thereto and rights therein as may hereafter be brought within the jurisdiction of the corporation.
