TERMINATION OF TENANTS IN COMMON AGREEMENT

This Termination of Tenants in Common Agreement (this "Termination Agreement") is made and entered into this <u>47</u> day of February 2007, by GLENCOE CMX OWNER, LLC, a Delaware limited liability company ("Owner").

RECITALS

- A. Owner is the sole party to a certain Tenants In Common Agreement dated as of July 7, 2006 (the "TIC Agreement"), by which Owner established a tenancy-in-common regime to govern the ownership of that certain property described in Exhibit A attached hereto, commonly known as 2000 Frontage Road, Glencoe, County of Cook, Illinois (the "Premises"). Owner is the sole "Tenant In Common" under the TIC Agreement.
- B. Owner made and entered into that certain Declaration of Tenants In Common Agreement dated as of July 7, 2006, and recorded on August 3, 2006 as Document No. 0621548062 which memorialized the TIC Agreement (the "Declaration").
 - C. Owner desires to terminate the TIC Agreement and the Declaration.

NOW, THEREFORE, in consideration of the benefits to be derived herefrom, the receipt and sufficiency of which are hereby acknowledged by each of the parties hereto, it is hereby agreed as follows:

1. <u>Termination of TIC Agreement and Declaration</u>. The TIC Agreement and the Declaration are terminated as of the date first set forth above (the "Termination, Fate").

2. <u>Miscellaneous</u>.

- (a) <u>Amendment</u>. This Termination Agreement may only be amended by a written instrument that has been duly executed by the signatures of the parties hereto.
- (b) <u>Successors and Assigns</u>. This Termination Agreement will mure to the benefit of and bind the permitted successors, assigns, heirs, and personal representatives of the parties.
- (c) <u>Applicable Law.</u> This Termination Agreement shall be governed by, and construed in accordance with, the laws of the State of Illinois without reference to its conflict of law principles.
- (d) <u>Captions</u>. Captions and section headings are used herein for convenience only. They are not part of this Termination Agreement and shall not be used in construing it.
