SUBORDINATION AND CONSENT

NOW, THEREFORE, in consideration of the foregoing recitals and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, FSM and Selier hereby consent to the execution, delivery and recording of the Mortgage and hereby subordinate their respective rights and obligations under the Repurchase Option to the liens, rights and obligations created by the Mortgage.

Sun Life Assurance Company of Canada is an intended beneficiary of this Subordination and Consent and shall have the right to enforce it.
