I, LARRY M. DREYFUS, hereby depose and state under oath that:

1. I am an attorney licensed to practice law in the State of Illinois, and have been so continuously since 1979. My address is:

- 2. In 2006 I represente à Anastasios J. Manolas, Maria Manolas and H. Robert Bartell III for their purchase of certain real estate, commonly known as Unit 3101 in the 5455 Edgewater Plaza Condominium, located at 5455 N. Sheridan Road (hereinafter-"Property"). The legal description of the Property is provided below.
- 3. The deed that Anastasios J. Manolas, Maria Manolas and H. Robert Bartell III received from the Grantor on or about April 27, 2006 marked by the Cook County Recorder as Doc# 0613802116 and recorded on May 18, 2006, accurately described the title that Anastasios J. Manolas, Maria Manolas and H. Kobert Bartell II desired.
- 4. Said deed states that Anastasios J. Manolas, Maria Manolas and H. Robert Bartell III took title to the Property all as "joint tenants with the light of survivorship", and not as tenants in common.
- 5. It was the intent of Anastasios J. Manolas, Maria Manolas and H. Robert Bartell III for all of them to own the Property as "Joint Tenants" so that in the event that either of them pre-deceased the others, the survivors of them would exclusively own the Property. I personally explained the above to each of them; and each responded that they understood.
- 6. Specifically with respect to Anastasios J. Manolas, who was in ill health and an older man facing his mortality, he stated to me during the process to purchase the Property that it was his intent that upon his death for his interest in the Property to go to his daughter, Maria Manolas and her husband, H. Robert Bartell.
- 7. Anastasios J. Manolas explained to me that his decision to be a "Joint Tenant" in said Property with his daughter, Maria Manolas and her husband, H. Robert Bartell, and not Tenants In Common, was as part of his estate plan.
- 8. On or about April 3, 2007, Anastasios J. Manolas died. Attached to this Affidavit is a certified "Medical Certificate Of Death", documenting his death.

- 9. It is my legal opinion that upon the death of Anastasios J. Manolas title to the Property, as a matter of law, instantly vested in Maria Manolas and H. Bartell, III, as joint tenants with the right of survivorship, and not as tenants in common.

Party of the first part also hereby grants to the party(s) of the second part, his (their) successors and assigns and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the Declaration of Condominium, aforesaid, and party of the first part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein and the right to grant said rights and easements in conveyance and mortgages of said remaining property.

The Deed is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said Declaration the same as thought the provisions of said Declaration were recited and stipulated at length therein.
