


Lender may require Borrower to pay a one-time charge for a real estate tax verification and/or reporting service used by Lender in connection with this Loan.

5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. 

If Borrower abandons the Property, Lender may file, negotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. - 7. Preservation, Maintenance and Protection of the Property; Inspections. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate or commit waste on the Property. Whether or not Borrowe is residing in the Property, Borrower shall maintain the Property in order to prevent the Property from deteriorating or decreasing in value due to its condition. Unless it is determined pursuant to Section 5 that relair or restoration is not economically feasible, Borrower shall promptly repair the Property if damaged a avoid further deterioration or damage. If insurance or condemnation proceeds are paid in connection with camage to, or the taking of, the Property, Borrower shall be responsible for repairing or restoring the Property only if Lender has released proceeds for such purposes. Lender may disburse proceeds for the repairs and restoration in a single payment or in a series of progress payments as the work is completed. Borrower shall be in default if, curing the Loan application process, Borrower or any persons or entities acting at the direction of Borrower or with Borrower's knowledge or consent gave materially false, misleading, or inaccurate information or stauments to Lender (or failed to provide Lender with material information) in connection with the Loan. Material representations include, but are not limited to, representations concerning Borrower's occupancy of the Property as Borrower's principal residence.
- 9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. If (a) Borrower fails to perform the covenants and agreements contained in this Security Instrument, (b) there is a legal proceeding that might significantly affect Lender's interest in the Property and/or rights under this Security Instrument (such as a proceeding in bankruptcy, probate, for condemnation or forfeiture, for enforcement of a lien which may attain priority over this Security Instrument or to enforce laws or regulations), or (c) Borrower has abandoned the Property, then Lender may do and pay for whatever is reasonable or appropriate to protect Lender's interest in the Property and rights under this Security Instrument, including protecting and/or assessing the value of the Property, and securing and/or repairing the Property. Lender's actions can include, but are not limited to: (a) paying any sums secured by a lien which has priority over this Security Instrument; (b) appearing in court; and (c) paying reasonable



Mortgage insurers evaluate their total risk on all such insurance in force from time to time, and may enter into agreements with other parties that share or modify their risk, or reduce losses. These agreements are on terms and conditions that are satisfactory to the mortgage insurer and the other party for parties) to these agreements. These agreements may require the mortgage insurer to make payments using my source of funds that the mortgage insurer may have available (which may include funds obtained from Nortgage Insurance premiums).

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or might be characterized as) a portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. 



#### (D) The Index

Beginning with the first Interest Rate Change Date, my interest rate will be based on an Index. The "Index" is a Twelve Month Average of the monthly yields ("Monthly Average Yields") on United States Treasury securities adjusted to a constant maturity of one year ("MTA"), as made available by the Board of Governors of the Federal Reserve System in the Federal Reserve Statistical release NO. H. 15 entitled "Selected Interest Rates." The Twelve Month Average is determined by adding together the Monthly Average Yields for the preceding twelve months most recently available as of the date 15 days prior to the Interest Rate Change Date, and dividing the result by twelve. The most recently available as of the date 15 days before each Interest Rate Change Date is called the "Current Index."

If the Index or any Index previously substituted under this Section 2 (D) is no longer available, or is clocawise unpublished, the Note Holder may choose a new Index and a new Margin to result in a rate similar to the rate in effect at that time which is based upon comparable information. Note Holder will give me notice of the choice.

#### (E) Calculation of Interest I at Changes

Before each Interest Rate Change Date, the Note Holder will calculate my new interest rate by adding Three and 400/1000 percentage points (3.400%) (the "Margin") to the Current Index. The Note Holder will then round the result of this addition to the nearest one-ciganh of one percentage point (0.125%). #### (iii) Other Changes.

My monthly payment may also change as described in Section (F) below.

#### (E) Payment Options
