TO HAVE AND TO HOLD said premises forever.

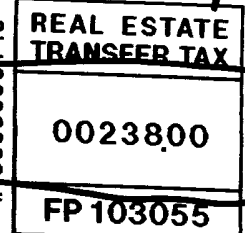
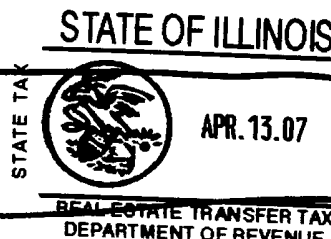
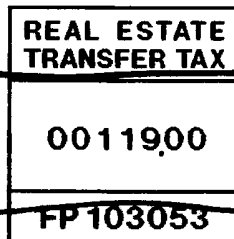
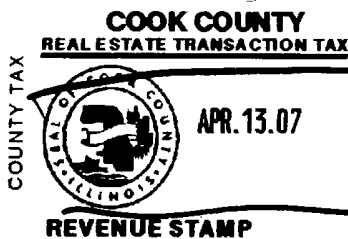
