- 2. Exhibit "A" attached to said declaration is hereby deleted and Exhibit "A" attached hereto and made part of hereof shall be and hereby is substituted therefore.
- 3. Page 1 of 7, Page 3 of 7, and Page 7 of 7 of Exhibit "D" attached to said declaration are hereby deleted and Page 1 of 7, Page 3 of 7, and Page 7 of 7 of Exhibit "D" attached hereto and made part of hereof shall be and hereby are substituted therefore.
- 4. All other provisions remain the same.
