UNIFORM COVENANTS.

Mortgagor and Lener covenant and agree as follows:

- 1. PAYMENT OF PRINCIPAL AND INTEREST. Mortgagor shall promptly pay when due the principal and interest indebtedness evidenced by the Note and late charges as provided in the Note.
- 2. APPLICATION OF PAYMENTS. Unless applicable law provides otherwise, all payments received shall be applied by Lender first to interest payable on the Note and then to the principal of the Note.
- 3. PRIOR MORTGAGES AND DEEDS OF TRUST. Mortgagor shall perform all of Mortgagor's obligations under any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage, including Mortgagor's covenants to make payments when due. - 4. HAZARD INSURANCE. The insurance carrier providing the insurance shall be chosen by Mortgagor subject to approval by Lender; provided that such approval shall not be unreasonably withheld. - 7. INSPECTION. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Mortgagor notice prior to any such inspection specifying reasonable cause therefore related to Lender's interest in the Property.
- 8. CONDEMNATION. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender, subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage.
- 9. MORTCAGOR NOT RELEASED; FORBEARANCE BY LENDER NOT A WAIVER. Extension of the time for payment or modification of amortization of the sums secured by this Mortgage granted by Lender to any successor in inerest of Mortgagor shall not operate to release, in any manner, the liability of the original Mortgagor and Mortgagor's successors in interest. The receiver shall be liable to account only for those rents ac'ually received.

- 19. RELEASE. Upon payment of all sums secured by this Mortgage, Lender shall release this Mortgage without charge to Mortgagor. Mortgagor shall pay all costs of recordation, if any.
- 20. WAIVER OF HOMESTEAD. Mortgagor hereby waives all right of homestead exemption in the Property.
