### MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT ("Memorandum") is made as of this day of April, 2007, by and between 1% ORCHARD LLC ("120"), 427 ORCHARD LLC ("427") and FT ORCHARD LLC ("FT"), each a Delaware limited liability company.

#### RECITALS:

- A. 120, 427 and FT each individually own a tenant in common interest in certain property commonly known as the Orchard Place Shopping Center, Skokie, Illinois as legally described as Exhibit A attached hereto and incorporated by reference (the "Property").
- B. 120, 427 and FT have entered into a certain Limited Co-Ownership Agreement dated even date herewith with respect to the Property (the "LCOA").
- C. The parties hereto desire to provide notice of the LCOA to the parties by recording this Memorandum.
- NOW, THEREFORE, in consideration of the mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each party hereto agrees that the ownership of its tenant in common interest in the Property shall be subject to the terms and provisions of the LCOA. The parties further agree that while such time as the loan made by JP Morgan Chase Bank, N.A. in the original principal amount of \$35,000,000 secured by the Property remains unpaid each party waives its right to bring an action for partition with respect to the Property.

This Memorandum of Agreement may be executed in multiple counterparts each of which will be deemed an original but together will constitute one instrument.
