LINE OF CREDIT ODIFICATION AND EXTENSION AGREEMENT

- None of the rights of Mortgagee under the Loan Documents shall be prejudiced by leason of this 4. Agreement and this Agreement shall not affect the lien and charge of the Loan Documents upon the property covered thereby.
- Mortgagor hereby acknowledges and agrees that the Loan Documents remain in full force and 5. effect, except as they have been expressly modified by the terms of this Agreement. In other respects not inconsistent with this Agreement, the terms of the Loan Documents are hereby ratified and reconfirmed.
