# DECLARATION OF ASSIGNMENT AND TRANSFER OF STORAGE LOCKER AND AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR THE 2000 NORTH LINCOLN PARK WEST PRIVATE RESIDENCES, A CONDOMINIUM

This Declaration made this 20 n day of March, 2007, by 2000 North Lincoln Park West, LLC, an Illinois limited liability company, located at 2627 Nor h Clark Street, Chicago, Illinois 60614 (Transferor), as Developer of 2000 North Lincoln Park West Private Residences, a Condominium (the Condominium), and the Robin M. Arkin Revocable Trust, as legal title owner of Condominium Unit 1602 located at 2000 North Lincoln Park West, Chicago, Illinois 60614 (Transferee).

WHEREAS, Transferor, as owner of Unit 1(02, has the right to the exclusive use and possession, as a Limited Common Element, of S16-L and S16-R, and

WHEREAS, Transferee, as the owner of Condominium 10 it 1602, which is legally described on Exhibit A attached hereto, desires to acquire the right to the exclusive use and possession, as a Limited Common Element, of S16-L and S16-R, which Storage Locker is located at the Condominium, and

WHEREAS, Transferor and Transferee desire that the right to the exclusive use and possession of S16-L and S16-R be transferred and assigned to transferee as the owner of Condominual Unit 1602.

NOW, THEREFORE, pursuant to the terms of the Condominium Property Act of the State of Illinois and of the Declaration of Condominium for the 2000 North Lincoln Park West Private Residences, a Condominium, recorded in the Office of the Recorder of Deeds of Cook County on December 13, 2004, as Document No. 0434834091, as amended, the parties agree as follows:

- 1. Transferor hereby assigns to Transferee, as owner of Condominium Unit 1601, the right to the exclusive use and possession of S16-L and S16-R, as a Limited Common Element, which right shall be appurtenant to and serve exclusively said Condominium Unit 1602. No other Unit Owners have any right to the use or possession of S16-L and S16-R.
- 2. The right to the use and possession of S16-L and S16-R being transferred and assigned hereunder is subject to: (a) the Condominium Property Act of the State of Illinois and the Municipal Code of the City of Chicago; (b) the Condominium Declaration and any amendments thereto; (c) such rules and regulations as the Board of Directors of the Condominium may from time to time prescribe; (d) existing leases, liens and encumbrances of Directors of the Condominium Unit to which S16-L and S16-R is assigned by this Declaration; and (e) the right of the Association to run utility lines and service through the Storage Locker and Storage Area in which it is contained as necessary for the Association.
