AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND BY-LAWS EASEMENTS, RESIDICTIONS AND EASEMENTS FOR CINEMA LOFTS CONDOMINIUM ASSOCIATION TO TRANSFER LIMITED COMMON ELEMENTS

This Amendment to the Declaration of Condominium Ownership and By-Laws Easements, Restrictions and Covenants for Cinema Lofts Condominium Association to Transfer Limited Common Elements ("Amendment") is made May 25, 2007, by William. Gonzalez and Shirley Gonzalez (collectively, "Gonzalez").

- 2. Parking Space P-142 currently assigned to Unit 511 is hereby reassigned to Unit 418.
