- 4. Upon the death, dissolution or liquidation of any of the undersigned, or any endorser, guarantor or surety hereto.
- 5. Upon the filing by any of the undersigned of an assignment for the benefit of creditors, bankruptcy or for relief under any provisions of the Bankruptcy Code; or by suffering an involuntary petition in not vacated within 30 days.
