SPECIAL WARRANTY DEED

THIS INDENTURE, is made as of May 18, 2007 between **740 W. Addison, LLC**, an Illinois limited liability company ("Grantor"), having an address of 724 N. 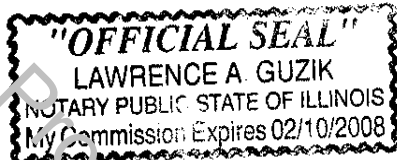
