AGREED ORDER OF JUDGMENT AND ENFORCEMENT WITH SETTLEMENT

THIS CAUSE coming on to be heard by the Court, the Court having heard evidence and testimony and having made a finding of Full Compliance / Substantial compliance subject to reinspection (circle one) of the violations listed in the Plaintiff's complaint;

IT IS HEREBY ORDERED THAT:

- 1. The judgment entered on the date of 5/1/07 in the amount of \$ 5,000.00 plus \$60.00 court costs for a total of \$ 5,060.00 against Defendants North Development, Ltd shall stand as final judgment on Count I of Plaintiff's complaint. 2. Plaintiff agrees to accept \$ 2,500.00 in full settlement of the judgment if payment is made to the City of Chicago by June 1, 2007. 3. If this case is dismissed subject to reinspection, Defendant must call the assigned City inspector at (312) 74(-) within 7 days to arrange for an interior inspection of the subject premises.
4. This order is final and appealable, there being no just reason to delay its enforcement or appeal.
