This matter coming to be heard on Plaintiff the City of Chicago's (the "City") Motion for Satisfaction of Judgment, Vesting of Title, and Possession, due notice having been given, and this Court being fully advised in the premises;

THE COURT HEREBY FINDS:

1. On March 22, 2007, this Court entered an Agreed Final Judgment Order requiring the sum of \$465,000.00 be deposited with the Treasurer of Cook County as final just compensation for the fee simple taking of the property commonly known as 3859-3861 S. Lake Park Avenue, Chicago, Illinois, PIN No. 17-35-104-007 and -008 and legally described as:

THE NORTHERLY 47 FEET OF THE SOUTHERLY 50 FEET OF LOT 7 AND THAT PART OF A STRIP OF LAND FORMERLY ALLEY NOW VACATED EAST OF AND ADJOINING THE NORTHERLY 47 FEET OF THE SOUTHERLY 50 FEET OF LOT 7 AFORESAID ALL IN BLOCK 3 IN CLEAVERVILLE IN THE SOUTHWEST FRACTIONAL 1/4 OF SECTION 35, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.
