MEMORANDUM OF ASSIGNMENT

This MEMORANDUM OF ASSIGNMENT (this "**Memorandum**") is made as of April 20, 2007 between **Wireless Capital Partners, LLC**, a Delaware limited liability company ("**Assignor**"), and **MW Cell REIT 1 LLC**, a Delaware limited liability company ("**Assignee**").

1. Assignor and Swedish American Museum Association of Chicago, a Illinois non-profit corporation, as Landlord, are parties to a Purchase and Sale of Lease and Successor Lease dated November 17, 2005 (the "**Agreement**"), a memorandum of which was recorded in Cook County, IL on 12/19/05 in/as #0535345079, relating to an interest in the real property described on attached Schedule A. Pursuant to an assignment dated April 20, 2007, a memorandum of which is about to be recorded immediately prior hereto, WCPWLS transferred and assigned all of its right, title and interest in and to the Agreement and the subject matter thereof including, without limitation, all amounts due and payable thereunder, to Assignor.

Pursuant to an Assignment dated April 20, 2007 (the “Assignment”): (i) Assignor has transferred and assigned, and in confirmation thereof hereby transfers and assigns, all of its right, title and interest in and to the Agreement and the subject matter thereof including, without limitation, all amounts due and payable thereunder, to Assignee; and (ii) Assignee has assumed all liabilities of Assignor under the Agreement which accrue or relate to the period from and after the date hereof.

4. Assignor executes this Memorandum to provide constructive notice of the existence of the Assignment, and of Assignee’s rights and obligations under the Assignment.

5. The terms and conditions of the Assignment are incorporated herein by reference as if set forth herein in full. Copies of the Agreement and the Assignment are maintained by WCF at its offices at 11900 West Olympic Boulevard, Suite 400, Los Angeles, California 90064.

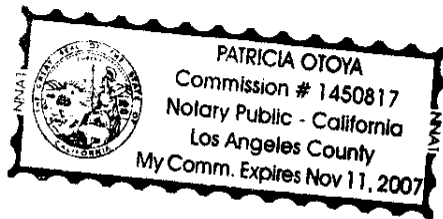
