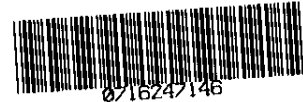

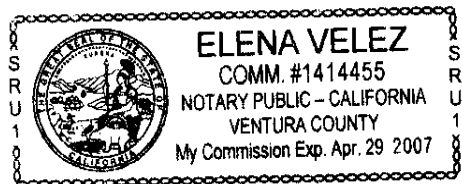

### LEGAL DESCRIPTION RIDER
