

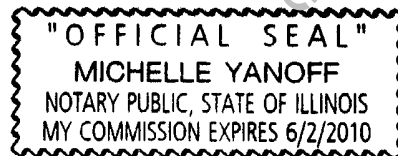

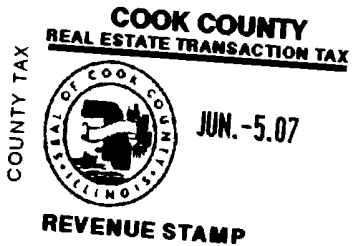

## LEGAL DESCRIPTION

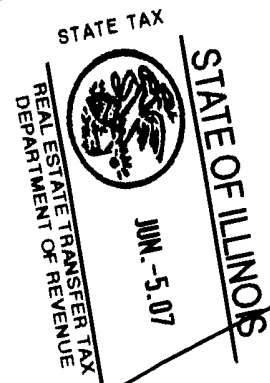

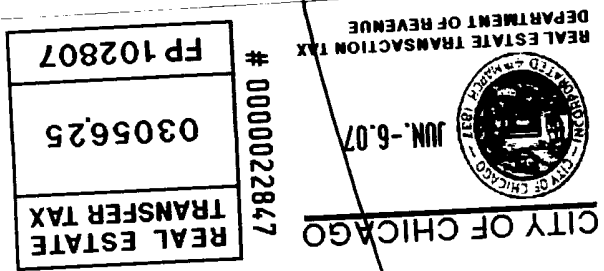
