creation of a lien for the monthly assessments or charges imposed pursuant thereto, together with interest, and costs of collection, such as attorneys fees.

That the balance of the aforesaid charges due, unpaid and owing pursuant to the aforesaid Declaration after allowing all credits, is the sum of \$2,925.76 through June 15, 2007. Each monthly assessment thereafter is in the sum of \$644.21 per month plus any special assessments.
