

- B. All future advances from Lender to Mortgagor or other future obligations of Mortgagor to Lender under any promissory note, contract, guaranty, or other evidence of debt executed by Mortgagor in favor of Lender after this Security Instrument whether or not this Security Instrument is specifically referenced. Mortgagor appoints Lender as attorney in fact to sign Mortgagor's name or pay any amount necessary for performance. 


