# SEVENTH AMENDMENT TO PROPERTY RIGHTS AGREEMENT FOR JAZZ ON THE BOULEVARD

THIS SEVENTH AMENDMENT TO PROPERTY RIGHTS AGREEMENT FOR JAZZ ON THE BOULFVARD ("Amendment to Property Rights Agreement") is entered into and effective as of June 23, 2007, by and between the Chicago Housing Authority (the "Authority"), an Illinois municipal corporation, with offices at 626 West Jackson Boulevard, Chicago, Illinois 60661, Jazz on the Boulevard LLC, a Delaware limited liability company ("Jazz") and Drexel Jazz Limited Partnership, an Uninois limited partnership (the "Partnership"). Capitalized terms not otherwise defined herein shall have the meaning set forth in that certain Property Rights Agreement (as amended, the "Property Rights Agreement") for Jazz on the Boulevard, dated as of August 1, 2004 and recorded in the Recorder's Office of Cook County on August 12, 2004 as Document No. 042501209, as amended by First Amendment thereto dated August 1, 2005 and recorded in the Recorder's Office of Cook County on November 21, 2005 as Document No. 0532527120, by Second Amendment thereto lated November 22, 2005 and recorded in the Recorder's Office of Cook County on November 23, 2005 as Document No. 0532741159, by Third Amendment thereto dated December 7, 2005 and recorded in the Recorder's Office of Cook County on December 12, 2005 as Document No. 0534645129, by Fourth Amendment thereto dated March 29, 2006 and recorded in the Recorder's Office of Cook County on March 30, 2006 as Document No. 0608927085 by Fifth Amendment Locreto dated August 8, 2006 and recorded in the Recorder's Office of Cook County on August 19, 2006 as Document No. 0622205156 and by Sixth Amendment thereto dated October 12, 2006 and recorded in the Recorder's Office of Cook County on October 13, 2006 as Document No. 0628620145.

### **WITNESSETH**

WHEREAS, the Authority, Jazz and the Partnership have previously excuted and recorded the Property Rights Agreement, which encumbers certain property, known as the "Development Parcels," described in Exhibit A thereto and imposes certain other obligations upon the Partnership; and

WHEREAS, Jazz has previously constructed condominium units on certain portions of the Development Site and has converted such units to a condominium form of ownership, pursuant to the Declaration of Leasehold Condominium for Jazz on the Boulevard Condominium (the "Leasehold Declaration"), Declaration of Condominium Ownership for 4162-4178 South Drexel Boulevard Condominium and Declaration of Condominium Ownership for 4136-4160 South Drexel Boulevard Condominium (the "Fee Declaration") which Leasehold Declaration

and Fee Declaration affect various portions of certain Parcels on Exhibit A to the Property Rights Agreement; and

WHEREAS, Jazz has previously constructed townhome units on the Development Site and conveyed certain townhome units to the Partnership which affect a certain portion of Parcel 4 on Exhibit A to the Property Rights Agreement; and

WHEREAS, Jazz has constructed thirteen (13) townhome units on the Development Site and will convey concurrently herewith two (2) townhome units to the Partnership, which townhome units affect a portion of "Parcel 4" on Exhibit A to the Property Rights Agreement and

WHEFEAS, the Authority desires to amend Exhibit A to the Property Rights Agreement so as to encumber the appropriate portions of the Development Site consisting of the 2 townhome units and the other units previously conveyed by Jazz to the Partnership, and to amend and restate such Exhibit in its entirety;

NOW THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, and of other valuable consideration, Jazz, the Partnership and the Authority each agree as follows:

SECTION 1. AMENDMENT Co EXHIBIT A. Exhibit A to the Property Rights Agreement is hereby amended and restated to read as set forth in Exhibit 1 of this Amendment to Property Rights Agreement.

SECTION 2. FULL FORCE AND EFFEC r. Except as amended by this Amendment to Property Rights Agreement, the terms of the Property Rights Agreement remain in full force and effect, and are incorporated herein by reference as though fully set forth herein.

SECTION 3. COUNTERPARTS. This Amendment to Property Rights Agreement may be executed in multiple counterparts, each of which shall be an original, but all of which shall constituent but one and the same agreement.
