AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF SCHAUMBURG – THE EASTERN PORTION OF 1131 S. BRAINTREE DRIVE

WHEREAS, the following described territory is unincorporated territory containing 60 acres or less wholly bounded by the Village of Schaumburg; and

WHEREAS, legal notices regarding the intention of the Village to forcibly annex said territory have been sent to all public bodies required to receive such notice by State Statute; and,

WHEREAS, the President and Village Board of Trustees of the Village of Schaumburg have determined that the annexation of said territory pursuant to the provisions of 65 ILCS 5/7-1-13, is in the best interest of the Village of Schaumburg; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SCHAUMBURG:

SECTION ONE: That the property legally described as:

THAT PART OF LOT 6416 VEICH CONSISTS OF THE WEST 24.75 FEET OF THE SOUTH 10 RODS AND 10.00 FELT OF THE SOUTHWEST QUARTER TO THE SOUTHWEST QUARTER OF SECTION TWENTY-EIGHT, TOWNSHIP FORTY-ONE NORTH, RANGE TEN EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS

as shown on the map which is attached hereto and made a part hereof as Exhibit A, be and it is hereby annexed to the Village of Schaumburg.

SECTION TWO: That the Village Clerk, be and is here by directed to file a certified copy of this ordinance together with an accurate map of the annexed territory in the Office of the Recorder of Deeds of Cook County and to file with the County Clerk a certified copy of this Ordinance, together with the accurate map of the territory annexed appended to this Ordinance.

SECTION THREE: This ordinance shall be in full force and effect from and ane: its passage, approval, and publication in the manner provided by law.


