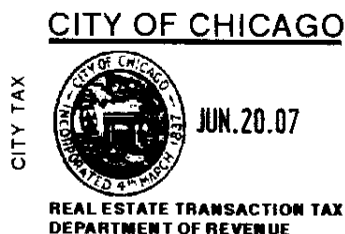
LEGAL DESCRIPTION FOR VB 1224 LOFTS CONDOMINIUMS
