FINAL JUDGMENT ORDER

THIS MATTER COMING on to be heard on Motion of the Plaintiff, THE DEPARTMENT OF TRANSPORATION, STATE OF ILLINOIS, for the Entry of a Final Judgment Order and upon the verified complaint of Plaintiff to ascertain just compensation for taking the property sought to be taken for highway purposes, as more fully set forth in the complaint, due notice having been given all parties entimed thereto;

The Plaintiff having appeared by LISA MADIGAN, Attorney General of the State of Illinois, and ROBERT W. FIORETTI, Special Assistant Attorney General;

All defendants having been served as provided by statute either by personal service or by publication, and Defendant, CNL NET LEASE INVESTORS, L.P. having encoded its appearance, and Defendants, HMS HOST FAMILKY RESTAURANTS, INC. 1/k/a MARRIOTT FAMILY and IHOP PROPERTIES, INC. and UNKNOWN OWNERS, having been found in default, and the Court having jurisdiction of this proceeding and of all parties hereto;

Due notice of this hearing having been given to all parties entitled thereto;

The Court having heard and considered the evidence and the representations of counsel, and being fully advised in the premises;

THE COURT FINDS:

1. The owner and interested party in Parcel 0EF0012PE, which is legally described in Exhibit A which is attached hereto and made a part hereof by reference is:

CNL NET LEASE INVESTORS, L.P.

- 2. Said party is entitled to receive the sum of ELEVEN THOUSAND FIVE HUNDRED DOLLARS (\$11,500.00) as full just compensation for the permanent easement to Parcel 0EF0012PE.
- 3. Just compensation to the owner and interested party for the taking of said permanent ensement is ELEVEN THOUSAND FIVE HUNDRED DOLLARS (\$11,500.00) and judgment is entered in said amount in favor of the Defendant, CNL NET LEASE INVESTORS, L.P. Said amount includes any claims for interest due from the Plaintiff to the Defendant.
- 4. A motion was made by the Plaintiff for the immediate vesting of title in the Plaintiff to a permanent easement in Parcel 0EF0012PE pursuant to the statutes thereto appertaining and on March 4. 2003, Plaintiff deposited with the Cook County Treasurer the sum found to be preliminary just compensation, and on March 13, 2003, the Court ordered that the Plaintiff be vested with title to the permanent easement to Parcel 0EF0012PE, and authorized Plaintiff to take possession thereof.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that no further monies be deposited with the Treasurer of Cook County and the payment of ELEVEN THOSUAND FIVE HUNDRED DOLLARS (\$11,500.00) to CNL NET LEASE INVESTORS, L.P. is full just compensation for the taking of the permanent easement to Parcel 0EF0012PE.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the judgment entered on January 15, 2003, in the sum of ELEVEN THOUSAND FIVE HUDNRED DOLLARS (\$11,500.00) which is full and just compensation for the permanent easement impressed on Parcel 0EF0012PE, be and the same is hereby declared satisfied and said judgment entered on January 15, 2003, against the Plaintiff is hereby released.
